- 第一條 本法依據國立中央大學學分抵免辦法訂定。
- Article 1 The regulation is made according to the regulations of credit transfer by National Central University.
- 第二條 曾修習物理系碩士班課程成績達 70 分（含）以上，且未計入學士班畢業學分者，得申請抵免學分。
- Article 2 Master students of the Physics Department can apply for credit transfer of master courses taken before if the course grade is 70 or higher and has not been used toward the undergraduate degree.
- 第三條 曾修習物理系碩士班課程成績達 70 分（含）以上，已計入大學部畢業學分者，不得抵免學分，但若為本系碩士班必修課程，得申請免修。
- Article 3 Master students who have taken a master course with a grade equal to or higher than 70 cannot apply for credit transfer of the course if the course credits have been used toward the undergraduate degree. But if the course is required by our Master Program, the student can apply for not taking the course again.
- 第四條 申請抵免之課程若屬本系碩士班課程則予以追認，若為本校或校外其他研究所課程，則須經過本系審核通過後追認之。
- Article 4 If the course for credit transfer is offered in our Master Program, it is recognized. If the course is offered by other departments of our University or other colleges, it shall be reviewed. However, the course grade will not be averaged with others in that semester.
- 第五條 符合本辦法第二條之條件者，抵免總學分不限，但在碩士班修業期間必須修習至少一門本系研究所 2 學分（含）以上非專題課程。
- Article 5 Students who meet the requirement in Article 2 can apply for credit transfer without any limit on the total transfer credit. But they should take at least

one non-special topic course of 2 or more credits.

第六條 本辦法如有未盡事宜，依教育部及本校有關規定辦理。

Article 6 If there is any ambiguity or incompleteness in this regulation, please refer to related regulations set by the Ministry of Education and National Central University.

第七條 本辦法經物理系系務會議通過並送教務會議核備後實施，修正時亦同。

Article 7 This regulation will take effect after being approved by the Department Affair's Meeting and then passed by the Academic Affair's Meeting. The same procedure should be followed if the regulation is to be revised.
