第一條 本要點係依據「國立中央大學博士班、碩士班學位考試細則」第四條與「國立中央大學學則」第五十六條之二規定訂定之。

第二條 博士學位考試委員，除對博士學位候選人所提論文學科、創作或技術報告有專門研究外，另依下列規定辦理提聘資格認定：

- 一、具有曾任教授、中央研究院院士或曾任中央研究院研究員者得直接提聘。
- 二、其若為下列之一者，由本系常務委員會審查：
 - (一) 曾任副教授或擔任中央研究院副研究員，在學術上著有成就者。
 - (二) 獲有博士學位，在學術上著有成就者。
 - (三) 屬於稀少性或特殊性學科，在學術或專業上著有成就者。

第三條 碩士學位考試委員，除對碩士班研究生所提論文學科、創作或技術報告有專門研究外，另依下列規定辦理提聘資格認定：

- 一、具有曾任教授、副教授、助理教授、中央研究院院士或曾任中央研究院研究員、副研究員、助理研究員得直接提聘。
- 二、其若為下列之一者，由本系常務委員會審查：
 - (一) 獲有博士學位，在學術上著有成就者。
 - (二) 屬於稀少性或特殊性學科，在學術或專業上著有成就者。

第四條 本辦法如有未盡事宜，依教育部及本校有關規定辦理。

第五條 本要點經系務會議通過，修正時亦同。

Guidelines for Qualification of PhD/Master Thesis Advisor and Degree
Examination Committee Member

Passed by the Academic Affairs Meeting on February 24, 2009

1. These guidelines are established in accordance with the Article 4 of “Examination Rules of Degree for Master and Ph.D. Candidates, NCU” and Article 56.2 of “General Rules and Regulations, NCU.”

2. In addition to having expertise in the field of the thesis, invention, or technical report proposed by the PhD candidate, the qualification of the PhD degree examination member is further judged according to the following standards:
 - (a) A person who has been a full professor, an academician of Academia Sinica, or a research fellow of Academia Sinica, is certainly qualified.
 - (b) The person who satisfies one of the following qualifications should be reviewed by the Regular Affairs Committee of the Department:
 - (i) The person has been an associate professor or an associate research fellow of Academia Sinica, and has prominent academic achievements.
 - (ii) The person has a doctoral degree and has prominent academic achievements.
 - (iii) The person is an expert in a unique or special field, and has prominent academic or professional achievements.

The academic or professional field of the person satisfying one of the above three qualifications is determined by the General Affairs Committee of the Department.

3. In addition to having expertise in the field of the thesis, invention, or technical report proposed by the PhD candidate, the qualification of the master degree examination member is further judged according to the following standards:
 - (a) A person who has been a full professor, an associate professor, an assistant professor, an academician of Academia Sinica, or a research fellow, an associate research fellow, or an assistant research fellow of Academia Sinica, is certainly qualified.
 - (b) The person who satisfies one of the following qualifications should be reviewed by the General Affairs Committee of the Department:
 - (i) The person has a doctoral degree and has prominent academic achievements.
 - (ii) The person is an expert in a unique or special field, and has prominent academic or professional achievements.

The academic or professional field of the person satisfying one of the above two qualifications is determined by the General Affairs Committee of the Department.

4. If the guidelines are anywhere incomplete, students should consult with the related rules set by

the University and the Ministry of Education.

5. The guidelines will be enforced after the approval by the Department Academic Affairs Meeting and recorded at the Office of Academic Affairs. Corrections to the guidelines shall be done through the same procedure.
