1. Check the Thesis Title.

The thesis title on the cover of the thesis and in the Verification Letter from the Oral Examination Committee should be **identical** to that in the Oral Examination Report for the Oral Examination Committee.

If you complete the graduation and school-leaving procedures (having completed the school-leaving process and having received your diploma) in February 2021, the month printed on the cover of your thesis should be February. If the procedures are completed (having completed the school-leaving process and having received your diploma) in March, the month printed on the cover should be March; so on and so forth. However, if you complete the graduation and school-leaving procedures in June, July, and August, you technically graduate in June. Therefore, please print June 20XX on the cover of your thesis.
